# 91st Annual Meeting

The 91st Annual Meeting of the Waterbury Connecticut Teachers Federal Credit Union will be held on **Thursday**, **May 22, 2025, at 3:30 PM in the Conference Room at the Courtyard by Marriott Hotel, 63 Grand Street, Waterbury, CT 06702**.

The nominating committee has filed the names of the following nominees for five positions on the Board of Directors to be voted on at the 2025 Annual Meeting:

**Joseph DelDebbio**, a Waterbury teacher and current Secretary of the Board of Directors, for a three-year term.

**Thomas Fava,** a retired Watertown teacher and current member of the Board of Directors, for a three-year term.

Karlyn Fitzpatrick, a Waterbury school administrator and current member of the Board of Directors, for a three-year term.

**Nilda Almonte,** a Danbury teacher elected by the Board of Directors to fill the vacancy created by the resignation of Susan Troupe, for a one-year term.

Janet Sweetland, a Watertown teacher elected to the Board of Directors to fill the vacancy created by the passing of John Fontane, for a two-year term.

Nominations for vacancies for the Board of Directors may also be made through a petition signed by 1% of the membership. Each nominee by petition shall submit a statement of qualifications and biographical data with the petition. Each nomination must be accompanied by a signed certificate from the nominee stating that he or she is agreeable to the nomination and will serve if elected to office. Such nomination must be filed with the Nominating Committee, on or before March 21, 2025. Members of the Nominating Committee are Robert Haxhi, Lory Park-Knowles and Christopher Russo.

All elections shall be determined by a plurality vote and shall be by ballot except where there is only one nominee for each position to be filled. Nominations shall not be made from the floor unless sufficient nominations have not been made by the nominating committee or by petition to provide for one nominee for each position to be filled, or circumstances prevent the candidacy of one nominee for a position to be filled. Only those positions without a nominee shall be subject to nominations from the floor. In the event nominations from the floor, when permitted herein, result in more than one nominee for a position to be filled, and when nominations have been closed, tellers shall be appointed by the Chairman, ballots shall be distributed, the vote shall be taken and tallied by the tellers and the results announced. When only one member is nominated for each position to be filled, the chair may take a voice vote or declare each nominee elected by general consent of acclamation at the Annual Meeting.
